The Local Services Tax is a local tax due from all individuals who are employed within Unity Township. All Federal Employees and all Self-Reporting individuals who perform services of any kind or engage in any occupation or professions within Unity Township/Greater Latrobe School District are required to pay Local Services Tax.

Please complete and return the LST-3 form below with your payment due. If you have already paid the tax in another political subdivision, at another place of employment, provide this office with proof of payment. If your expected annual earnings are less than \$12,000, an exemption certificate may be completed for the Township amount of \$47.00. If your income is more than \$1000.00 and less than \$12,000.00 the \$5.00 School District portion of the tax must be paid. Return the forms below stating such, along with a completed exemption certificate and copy of your prior year tax return to our office

You may pay the tax \$13.00 quarterly as indicated on the Coupons or the one time full amount of \$52.00.
