TAX INFORMATION
PER CAPITA TAX

A per capita tax is a flat rate tax levied upon each individual, eighteen years of age or older residing within the taxing district. The tax has no connection with employment, income, voting rights or any other factor except residence within the community. Per capita tax for Unity Township is five dollars per individual, while per capita tax for Gr. Latrobe School District is ten dollars per individual. A combined per capita tax is billed on August 1 of each year.
