

### Internal Review and Recommendations

The permittee has applied for a renewal of Municipal Separate Storm Sewer System (MS4) National Pollutant Discharge Elimination System (NPDES) Permit No. PAI136135. PAI136135 was issued by the Pennsylvania Department of Environmental Protection (DEP) on November 15, 2018 and expired November 30, 2023.

The municipality has 300 outfalls with 10 identified as the most downstream on each relevant receiving stream. The outfalls represent the downstream most outfalls based on the MS4 Map provided with the application.

### Internal Review and Recommendations

The receiving streams for Unity Township's MS4 outfalls are part of the Kiskiminetas-Conemaugh River Watershed, for which a TMDL was finalized on January 1, 2010. Unity Township was assigned a wasteload allocation in the TMDL, which addressed impairments due to pH and acid mine drainage (AMD). Appendix A was included in the 2018 permit as a result of these impairments.

Sewickley Creek receives flow from several of Unity Township's MS4 outfalls and is impaired for Pathogens. Unity Township was therefore subject to Appendix B in the 2018 permit.

Unity Township discharges to two receiving stream that are impaired for siltation (Fourmile Run and Loyalhanna Creek) and two receiving stream that are impaired for suspended solids (Crabtree Creek and Monastary Run). Unity Township was therefore subject to Appendix E in the 2019 Permit. Appendix E required them to create and follow a Pollutant Reduction Plan (PRP). Unity township created a PRP, but has not completed the plan. Section E.A. of the 2018 permit required the permittee to complete a 10% reduction of defined loading rate by November 10, 2023. Unity Township did not comply with this requirement and operations intends to pursue the non-compliance.

Unity Township does not discharge to any stream for which there is an EPA approved TMDL for the watershed based on impairment from nutrients or sediment. The 2018 permit therefore did not include Appendix F and Unity Township was not required to create a TMDL Plan.

A full Compliance Report is provided in Attachment A.

Draft permit issuance is recommended.

### Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
